## **INVITATION TO BID**

***(First Publication)***

***NAME OF CONTRACT: Repair of Detour Bridge for the Improvement of Pula- Cawayan-Camandag FMR with Bridge***

***LOCATION: Baculon, Asipulo***

1. The ***Provincial Government of Ifugao***, through the ***SB No. 2, AO No. 2021-03 (20% DF), Counterpart to special Project (PRDP, Muyong Project- Debt Swap, CMGP, etc.)*** intends to apply the sum of ***One Million Three Hundred Eighteen Thousand Seventy Six Pesos & 33/100 (PhP 1,318,076.33)*** being the Approved Budget for the Contract (ABC) to payments under the contract for ***Publication No. 9- 2023- I (First Publication)***. Bids received in excess of the ABC shall be automatically rejected at bid opening. See attached “Annex A” for other information.
2. The ***Provincial Government of Ifugao*** now invites bids for the above Procurement Project. Completion of the Works is required within ***40 Calendar Days***. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from the Bids and Awards Committee Office of the Provincial Government of Ifugao and inspect the Bidding Documents at the address given below from ***8:00 AM to 5:00 PM, Monday to Friday***.
5. A complete set of Bidding Documents may be acquired by interested bidders on ***February 21, 2023 to March 14, 2023*** at the BAC Office, 3rd Floor, PEO Building, Capitol Compound, Lagawe, Ifugao and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of ***Five Thousand Pesos Only (Php 5,000.00) at the Provincial Treasury Office***. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person.
6. The ***Provincial Government of Ifugao*** through its Bids and Awards Committee will hold a Pre-Bid Conference on ***February 28, 2023 at 1:00 P.M. at the Bids and Awards Committee (BAC) Office, 3rd Floor, PEO Building, Capitol Compound, Lagawe, Ifugao***, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through, manual submission at the office address as indicated below, on or before ***March 14, 2023 at 1:00 P.M. at the Bids and Awards***

Late bids shall not be accepted.

8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 15.

Bid opening shall be on **March 14, 2023 at 1:00 P.M. basing on the BAC Wall Clock** at the **Bids and Awards Committee (BAC) Office, 3rd Floor, PEO Building, Capitol Compound, Lagawe, Ifugao.** Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

The **Provincial Government of Ifugao** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
